I, the undersigned Owner of the below-referenced Unit within Lakewood Prairie, hereby acknowledge receipt of and vote as follows for the Amendment to the Declaration:

_____ In favor of the Amendment to (a) remove the seven (7) year limitation to add additions to the property set forth in Article Two, Section 2.3 of the Declaration, (b) extend the time frame to seventy-two (72) hours set forth in Article Five, Section 5.2 of the Declaration, (c) allow seasonal or holiday lighting within 30 days of said season or holiday as set forth in Article Five, Section 5.8 of the Declaration, (d) allow all fencing to be no less than four (4) feet and no more than six (6) feet and set restrictions on corner Unit fences set forth in Article Five, Section 5.9.1 of the Declaration, (e) update the requirement for pool to be decked and skirted a minimum of twenty (20) percent of the circumference set forth in Article Five, Section 5.10 of the Declaration, (f) remove the seven (7) year restriction to change exterior color schemes set forth in Article Five, Section 5.14 of the Declaration, (g) remove the requirement that trashcans be kept in garages and allow exterior storage set forth in Article Six, Section 6.4 of the Declaration, and (h) limit election of board members to record Unit owners set forth in Article Seven, Section 7.2.1 of the Declaration, which will benefit the health, safety and welfare of the members of the Association.
