

TENANT - POOL MEMBERSHIP APPLICATION

IMPORTANT: An "Absentee Owner Statement (AOS)" form must be on file or must accompany this application along with a copy of the lease in order for pool privileges to be transferred from the OWNER to a TENANT. OWNER(S) MUST SIGN the Absentee Owner Statement and transfer their pool privileges before Tenants will be granted a pool membership. This application is to be used for all household members and must be completed by the **TENANT** to obtain pool membership. It can take up to 5 business days to process applications. Physical fobs are mailed to the address on file. Each household must elect to be issued one (1) physical fob **OR** a digital fob accessible via smartphone. All adult members may receive a digital fob. You must provide a copy of a valid government-issued photo ID with your current Lakewood address for each adult member.
